4. Obtain and maintain all permits, licenses and insurance required by State or Federal guidelines

**Rough & Ready Guide Services, Inc. will not be liable for the following circumstances:**

1. Illness resulting in loss of hunting days
2. Lack of physical condition on part of client resulting in a less than satisfactory hunt
3. For any delays or hunt cancellations caused by State or Federal hunting regulations
4. Lost hunting days to inclement weather or unforeseen equipment malfunctions
5. Cancellation by Client

1. Transport themselves to the point of departure designated by Kelly Vrem

4. Transport trophies from the nearest freight facility at his/her expense.
5. Discuss any problems/complaints before leaving, it is not possible to correct problems after hunt is over
6. Agrees and understands that in the event an animal is wounded and gets away, the animal is considered taken the Big Game Tag is forfeited and we will no longer pursue that species.
7. Maintain contact in the field with your Assistant or Registered Guide at all times.

I recognize that there is a significant element of risk in any outdoor activity. Knowing the inherent risk, danger and rigors involved in hunting, I certify that I am fully capable of participating in this activity. I assume responsibility for myself for bodily injury, death or loss of personal property as a result of my negligence. I understand that my Guide has First Aid and CPR training only and that we are not qualified to provide Emergency Medical Services beyond that.

### **Reservations:**

A 50% down-payment is needed to confirm your hunt, unless otherwise agreed to. The balance of your spring hunt is due February 15 and the fall hunt is July 1.

### **Cancellations:**

**We strongly suggest you check into Trip Insurance. Your Hunting Consultant or Travel Agent can assist you.**

If you cancel your confirmed hunt for the upcoming year or season you will not receive a refund, however you may sell your hunt to another party for the original dates. This transfer is your responsibility.

Hunts cancelled beyond one year may be refunded if the client or we can resell the hunt, less any commissions.

Forfeited hunts will be sold for the balance due. If you forfeit your down-payment or final payment you will be placed on a priority notification list to purchase another cancelled hunt in the future.

### **Changes in Regulations:**

In the event a regulatory action by the State of Alaska or the US Government prevent Rough and Ready Guide Service, Inc. from conducting a planned hunt, R&R has the right to offer the same or similar hunt at a future date. There are no refunds for this action.
